The SHLB Coalition advocates for government programs and policies that promote open, affordable, high-capacity broadband for anchor institutions and their communities. We file comments in regulatory proceedings, we convene conferences and events to promote the sharing of information and to foster collaboration among public and private sector organizations, and we sponsor research to highlight the broadband needs of anchor institutions.

The SHLB Coalition actively engaged with the FCC and other government agencies to reform programs funded by the Universal Service Fund (USF). The Coalition filed eight comments and letters with the FCC and held meetings with FCC officials regarding the E-rate, Lifeline and Rural Health Care Programs. Regarding the E-Rate Program, the Coalition successfully advocated that the E-rate Eligible Service List should allow schools and libraries to use dark fiber, lit fiber or any broadband technology that best suits their needs in the most cost-effective manner. The Coalition strongly supported the reform and modernization of the Lifeline Program to help low-income consumers obtain Internet connections. In its comments to the FCC, the Coalition supported including stand-alone broadband connectivity as a service funded by the Lifeline program. It argued that the increasing broadband adoption and making broadband service more affordable should be among the Lifeline Program's new performance goals. It encouraged the Commission to adopt a holistic approach to broadband that recognizes the role played by Community Anchor Institutions in broadband adoption. Also, it argued for no funding cap on the program. Each of these recommendations was adopted by the FCC in its Lifeline reform Order released in April 2016. In addition to its FCC activities, the Coalition filed comments with the Obama

4b (Code:) (Expenses \$ 24,990 including grants of \$ 0) (Revenue \$ 23,500)

The SHLB Coalition filed a Petition for Rulemaking with the FCC in December 2015 to modernize the Rural Healthcare Program. The SHLB Coalition assembled a group of six telehealth networks from California, Colorado, Montana, New England, New Mexico and Utah. The goal of the filing was to address how the FCC's Healthcare Connect Fund could be modernized to increase the availability of affordable, modern, quality broadband capable of meeting the needs of healthcare in the 21st century. These proactive telehealth networks met over a period of six months on conference calls led by the SHLB Coalition to discuss key barriers to rural healthcare delivery and how a modernization of the program could address these concerns. From these meetings, the group provided a roadmap of changes that the FCC should make to the program. The Petition recommended changes to incentivize greater investment in high-capacity health broadband networks, including recommendations to promote consortia applications, reduce the applicant match, facilitate public-private partnerships and adjust the definition of rural. In addition, the petition called for a number of changes to the administration of the program. The FCC put the Petition out for comment in early 2016 and most comments supported moving forward with the SHLB Coalition's recommendations.

The SHLB Coalition hosted three events in 2015 -- a Kansas Broadband Conference in January, an Annual Conference in May and the California AnchorNETs Conference in November. The SHLB Coalition contracted with the Kansas Department of Commerce to convene a statewide broadband conference, which attracted over 200 attendees. The SHLB Annual Conference attracted about 220 people, featured several FCC and NTIA speakers, state and local government leaders, anchor institutions, and many sectors of the broadband industry. The AnchorNETs Conference held in Mountain View, CA highlighted California's progress in promoting the development and utilization of broadband infrastructure for education, workforce development, government and healthcare, and to promote broadband adoption by citizens and communities. The agenda included several speakers from the California state government and from the NTIA. Together, these convenings met the SHLB Coalition's goal of promoting partnerships and collaboration and to advance an understanding of the broadband needs of anchor institutions.
