The Schools, Health and Libraries Broadband Coalition is a non-profit, 501(c)3 organization who seeks to address the "digital divide" by advocating for government policies that allow schools, libraries, health providers, commercial companies and others to invest in broadband networks that serve the public, especially in rural markets.

The SHLB Coalition held two events in 2017- its Annual Conference and a Fall Symposium. SHLB's Seventh Annual Conference, May 31 - June 2, was the most successful one to date. This conference focused on E-rate, Digital Inclusion, Telehealth, Financing, and the Trump Administration. It featured key government officials from the FCC and NTIA, local government leaders, and representatives from anchor institutions. In addition, SHLB saw a 33% increase in conference attendance. SHLB also hosted a Fall Symposium: Broadband4All in November to discuss the future of anchor institutions and the four Universal Service Fund (USF) programs. The Symposium helped applicants, state and local government officials, and broadband service providers understand and anticipate upcoming changes in the E-rate, Rural Health Care, Lifeline, and Connect America Fund programs.

In 2017, SHLB acquired 60 new members, bringing SHLB membership to 125 organizations. SHLB works hard to provide a forum for broadband advocacy where members share best practices, network and get regulatory and legislative updates. SHLB members become a part of a greater community. Members participate in bi-weekly policy calls, have advocacy input on SHLB's filings, speak at SHLB events, and have the opportunity to learn from other members. In addition, SHLB was proud to launch its new and improved Member Portal that provides access to archived webinars, resource libraries, recordings of policy calls with policymakers, and inside policy information. SHLB also launched its Calls with Policymakers series that gives the SHLB members the opportunity to directly ask government officials like FCC Commissioners Clyburn and O'Rielly questions.

The SHLB Coalition continued its strong emphasis on advocacy to promote high-quality broadband for schools, libraries, health providers and other anchor institutions. SHLB worked tirelessly in 2017 to address numerous broadband policy issues. In February 2017, SHLB released its Rural American Broadband Connectivity (ABC) Program proposal. The Rural ABC proposal emphasizes the importance of an open application process for federal funding to spur competition, network sharing to promote public-private partnerships, and coordinated and streamlined deployment, such as "dig once" and "make ready" policies. SHLB put forward these recommendations in a February letter to President Trump. SHLB has also been advocating for reform of the Rural Health Care program for the past two years and was pleased to see the FCC vote to begin the reform process in December 2017. The vote sought comment on increasing the cap for the RHC Program and other reforms to improve the operations and efficiency of the program. In addition, SHLB submitted comments to the FCC to support E-rate Funding for Category 2. SHLB signed onto a letter with 53 other organizations supporting Category 2 services. SHLB continues to strongly advocate to maintain and improve the
